The FTSE CNBC Global 300 Index is designed to show market performance across a broad range of countries and industries. Companies included in the FTSE CNBC Global 300 Index must be current constituents of the FTSE Global Equity Index Series, which incorporates developed and emerging markets.

The FTSE CNBC Global 300 Index comprises the largest 15 companies by full market capitalization from each of the 18 ICB Supersectors, plus the 30 largest companies from emerging markets.
