FEATURES

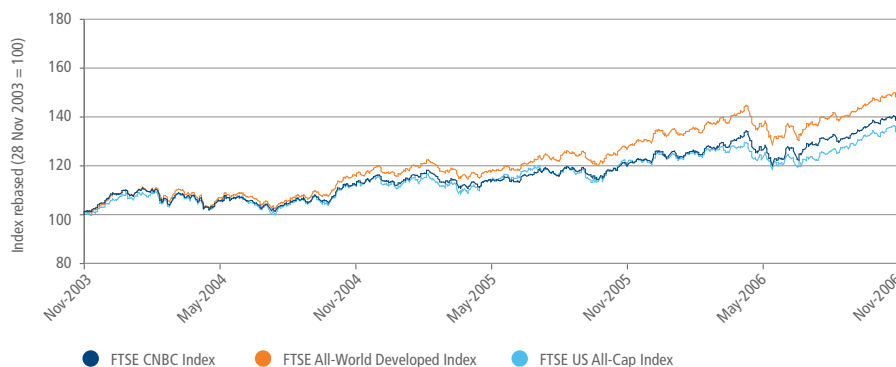
- Index constituents are derived from the FTSE Global Equity Index Series, which incorporates developed and emerging markets
- The index comprises the largest 15 stocks by full market capitalisation from each of the 18 Industry Classification Benchmark Supersectors (using FTSE All Cap Developed Index), as well as the 30 largest stocks from the emerging markets (using FTSE Emerging All Cap Index)
- The index maintains a fixed number of constituents
- Total and capital return indices are calculated for this index
- Stocks are free-float weighted to ensure that only the investable opportunity set is included within the index
- Stocks are liquidity screened to ensure that the index is tradable
- The series is calculated in accordance with the Industry Classification Benchmark (ICB), a global standard developed in partnership between FTSE Group and Dow Jones Indexes
- The index is designed for the trading of derivatives, index-tracking funds, ETFs and as a performance benchmark

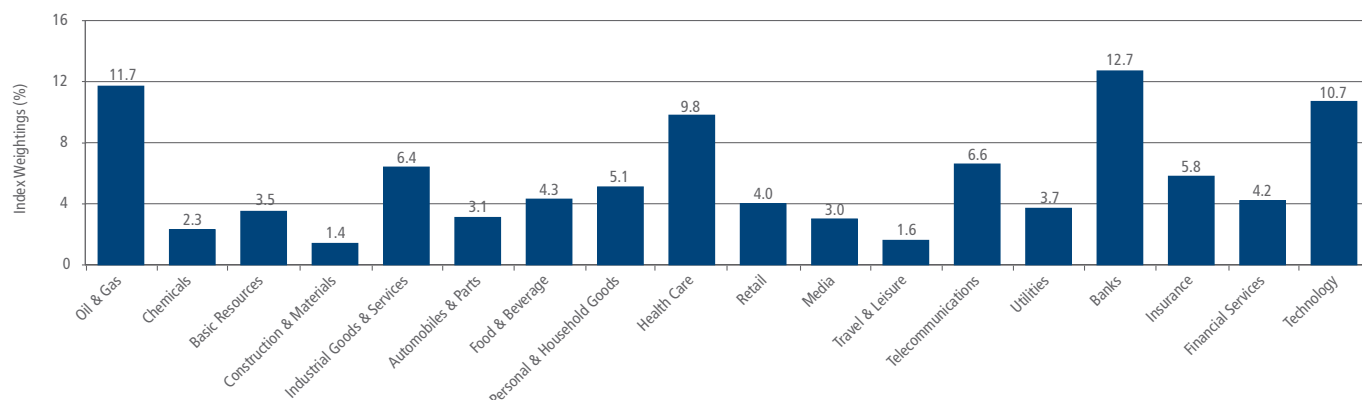
