INDEX SPECIFICATION

INDEX DESCRIPTION

- The FTSE EPRA/NAREIT Index Series REITs and Non-REITs are a sub-set of the FTSE EPRA/NAREIT Global Series that launched in February 2005. The REITs and Non-REITs Index Series will give investors the capability to view each constituent's classification within the EPRA/NAREIT universe according to REIT legislation. The FTSE EPRA/NAREIT Index Series REITs and Non-REITs will consist of 5 of the key indices split in to both REITs and Non-REITs indices plus 23 individual countries split into both REITs and Non-REITs indices, giving a total of 56 individual indices. The series will be provided as end of day products.
