INDEX DESCRIPTION

- The FTSE SGX Shariah Index Series is the result of a joint initiative between FTSE and the Singapore Stock Exchange to create a Shariah compliant index series. This initially comprises the FTSE SGX Asia Shariah 100 Index, which includes the following markets: Japan, Singapore, Taiwan, Korea and Hong Kong. The index is suitable for derivative trading, tracker funds and ETFs. Yasaar is responsible for reviewing the Shariah compliance of existing and prospective constituents of the FTE SGX Shariah Indices.
