The index is free float adjusted, liquidity tested and is managed by an independent committee to provide the most transparent and predictable view of the market.

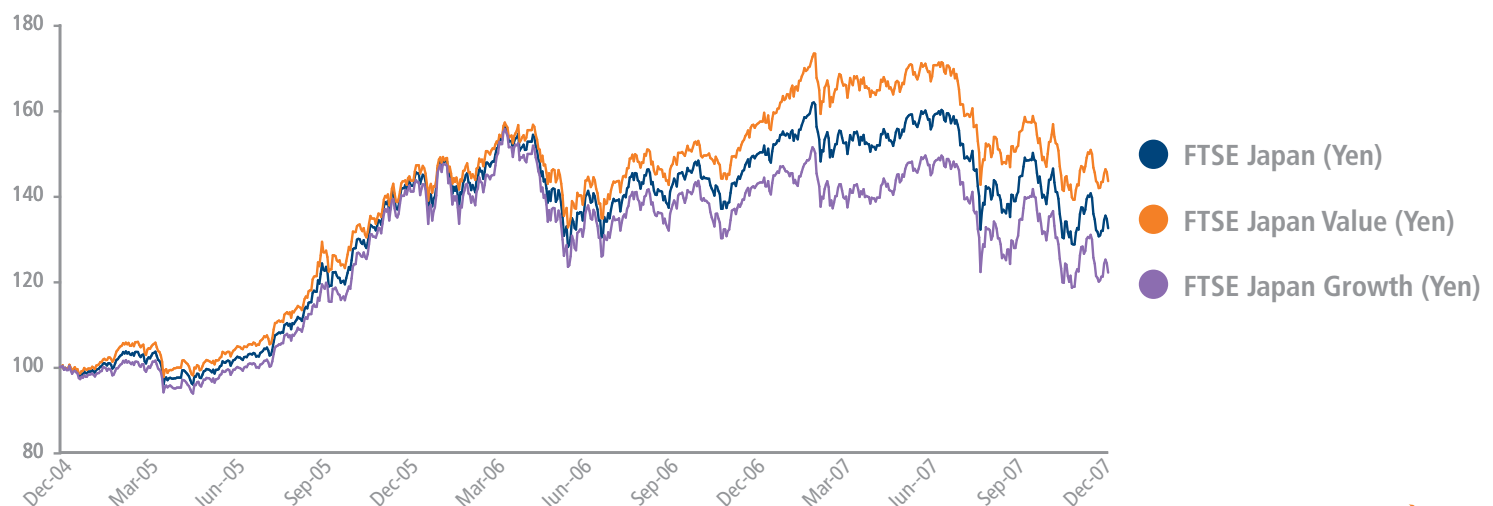
