

Alibaba Group Holding (China): Increase in Investability Weight

In relation to the public offering by Alibaba Group Holding (China) of its ordinary shares on the Hong Kong Stock Exchange, the beneficial ownership table in the public offering prospectus filed with the Hong Stock Exchange on 15 November 2019 confirmed that Altaba Inc. had disposed of its shareholding in Alibaba Group Holding. As a result and following an evaluation of Alibaba's current shareholder structure, FTSE Russell announces an increase in the investbaility weight of Alibaba Group Holdings from 55.1688931499% to 74.310925381858% within FTSE Russell indexes in conjunction with the December 2019 quarterly review, effective from the open on Monday, 23 December 2019.

This change will be reflected in FTSE Russell indicative review files from close on Wednesday, 04 December 2019.
