Further to the FTSE notice released on 29 October 2014 in relation to the FTSE Athex Index series review:

FTSE/Athex announces that due to the migration of the AthexGroup Trading & Clearing Systems into the OASIS system and the implementation of the new Derivatives Market Model which both go live on Monday, 1 December 2014, the implementation of the FTSE/Athex Index review will be postponed by one week, and therefore be effective at the open on **Monday, 8 December 2014**.

This decision was taken in order to mitigate any risk from the two actions taking place at the same time.

All other details remain unchanged.

FTSE/ATHEX-CSE Banking Index: Zero (0) additions, Zero (0) deletions and Zero (0) investability weight changes.

FTSE/ATHEX Market Index: Six (6) additions, nine (9) deletion and seven (7) investability weight changes.

FTSE/ATHEX Sector Indices: All changes in the composition of FTSE/ATHEX Market Index will be applied in the composition of the relevant FTSE/ATHEX Sector Indices.
